TENDER FOR SALE OF SKIMMED MILK POWDER

(TERMS AND CONDITIONS)

The Federation is interested to sell 500 MTs VERKA brand Skimmed Milk Powder (ISI Marked) in 25kg. bag packing manufactured and stored at affiliated Milk Unions situated in Punjab and invites sealed tenders from the interested parties on the following terms and conditions :-

1. The interested parties may offer quantity for purchase of SMP as per their requirement but minimum quantity offered should be 100 MT. The Federation will however be free to increase / decrease the quantity of Skimmed Milk Powder at the time of acceptance of offer.
2. The tenderer should quote the basic rate Per KG. on ex-Union/Factory basis. The amount should be indicated both in figures and words. The offer submitted in any other manner will be rejected. All other incidental charges such as VAT / CST, Transportation, Insurance etc.will be extra and borne by the Purchaser/ Tenderer. The delivery of SMP outside Punjab will be made against 'C' Forms. In case 'C' Forms are not submitted in advance, the tax lien in lieu of tax as applicable on SMP in Punjab will be kept with respective Milk Union/Plant which shall be refunded on submission of 'C' Forms.
3. The delivery of SMP will be made against 100% advance payment including taxes by way of Demand Draft / RTGS and the tenderer must lift the stock within the prescribed given period.
4. Earnest Money Deposit: The tender must accompany EMD of Rs.2.00 lacs (Rupees two lacs) per 100MT Skimmed Milk Powder by way of Demand Draft drawn in favour of "The Punjab State Cooperative Milk Producers' Federation Limited, payable at Chandigarh. The EMD will be converted in to Security Deposit of the successful tenderer and shall be refunded only after lifting the allotted stock and furnishing of 'C' Forms. No interest will be paid on Earnest Money Deposit / Security Deposit. The payment of EMD is compulsory for all the tenderers including Cooperative Federations / Dairies / Institutions.

The Earnest Money Deposit / Security Deposit alongwith amount deposited with the Federation, if any, will be forfeited for withdrawl of tender during the validity period, failure to lift the allotted stocks within the given period, pre-mature termination of contract for non-performance and violation of any terms & conditions of the tender.

5. The tenders submitted shall remain valid for acceptance for a period of 45 days from the date of the opening of tenders. A tender valid for a shorter period may be rejected as non-responsive.
6. The delivery of the SMP will be made after inspection by the authorized representative of the tenderer at respective Milk Union/Plant which will be final inspection.

7. In case of any dispute / question for controversy arising out of this contract, the same shall be referred to sole arbitrator of the Registrar, Cooperative Societies, Punjab, Chandigarh or his nominee whose decision should be firm and binding on both the parties. The provisions of The Punjab Cooperative Societies Act, 1961 as amended up to date shall also apply to Arbitration proceedings which shall be held at Chandigarh.
8. The successful tenderer will have to become Nominal Member of Milkfed as per Milkfed Bye-Laws with latest amendment after depositing the Membership Fee of Rs.1000/- (Rupees one thousand only) once for all (non-refundable) alongwith prescribed format.
9. In the event of any litigation arising out of this contract, the jurisdictional limit shall be Chandigarh City only.
10. The tender must accompany the attested copy of PAN Card, VAT/CST Registration Certificate and also FSSAI License.
11. The last date of receipt of tenders is 16.06.2015 upto 1.00 PM and will be opened on the same day at 3.00 PM in the presence of the tenderers or their authorised representatives. The conditional tender will not be accepted.
12. If the office happens to be closed on the date of receipt, then the tenders as specified, will be received and opened on the next working day at the same time and venue. However, the Federation reserves the right to extend the due date for submission of tender and date of tender and under such an event, the same will be communicated to all the concerned in advance.
13. The tenders should have "TENDER FOR SKIMMED MILK POWDER" superscribed on top of the envelope and addressed to the Managing Director, The Punjab State Cooperative Milk Producers Federation Limited, SCO no.153-155, Sector:34A, Chandigarh-160022.
14. Managing Director, The Punjab State Cooperative Milk Producers Federation Limited, Chandigarh reserves the right to accept any or reject any or all the tenders without assigning any reason whatsoever at any point of time.
15. The Federation reserves the right to add / delete any of the terms & conditions without assigning any reason thereof. Tenders not fulfilling terms and conditions are liable to be rejected. The Federation shall entertain no claim in this regard.
