TENDER FOR SALE OF WHITE BUTTER

(TERMS AND CONDITIONS)

The Federation is interested to sell 500 MTs VERKA brand White Butter in 15kg./20kg. packing manufactured at affiliated Milk Dairies, Ludhiana and Mohali & stored at Dairy or Warehouse of the Dairy in Punjab and invites sealed tenders from the interested parties on the following terms and conditions :-

1. The interested parties may offer quantity for purchase of White Butter as per their requirement but minimum quantity offered should be 100 MT. The Federation will however be free to increase / decrease the quantity of White Butter at the time of acceptance of offer.
2. The tenderer should quote the basic rate Per KG. on ex-Dairy/Factory basis for purchase of White Butter having 82% Milk Fat. The amount should be indicated both in figures and words. In case of any discrepancy in figures and words, the higher one would be considered. However, the rate will be calculated on pro-rata basis according to Milk Fat contents available in the White Butter. The offer submitted in any other manner will be rejected. All other incidental charges such as GST, Transportation, Insurance etc.will be extra and borne by the Purchaser/ Tenderer.
3. The delivery of White Butter will be made against 100% advance payment including taxes by way of Demand Draft / RTGS and the tenderer must lift the stock within the prescribed given period.
4. Earnest Money Deposit: The tender must accompany EMD of Rs.3.00 lacs (Rupees three lacs) per 100MT White Butter by way of Demand Draft drawn in favour of "The Punjab State Cooperative Milk Producers' Federation Limited, payable at Chandigarh. The EMD will be converted in to Security Deposit of the successful tenderer and shall be refunded only after lifting the allotted stock. No interest will be paid on Earnest Money Deposit / Security Deposit. The payment of EMD is compulsory for all the tenderers including Cooperative Federations / Dairies / Institutions.

The Earnest Money Deposit / Security Deposit alongwith amount deposited with the Federation, if any, will be forfeited for withdrawal of tender during the validity period, failure to lift the allotted stocks within the given period, pre-mature termination of contract for non-performance and violation of any terms & conditions of the tender.

5. The tender once submitted, cannot be cancelled / withdrawn. The tenders submitted shall remain valid for acceptance for a period of 30 days from the date of the opening of tenders. A tender valid for a shorter period may be rejected as non-responsive.
6. The delivery of the White Butter will be made after inspection by the authorized representative of the tenderer at respective Milk Dairy which will be final inspection.

In case of any dispute / question for controversy arising out of this contract, the same shall be referred to sole arbitrator of the Registrar, Cooperative Societies, Punjab, Chandigarh or his nominee whose decision should be firm and binding on both the parties. The provisions of The Punjab Cooperative Societies Act, 1961 as amended up to date shall also apply to Arbitration proceedings which shall be held at Chandigarh.
8. The successful tenderer will have to become Nominal Member of Milkfed as per Milkfed Bye-Laws with latest amendment after depositing the Membership Fee of Rs.1000/- (Rupees one thousand only) once for all (non-refundable) alongwith prescribed format.
9. In the event of any litigation arising out of this contract, the jurisdictional limit shall be Chandigarh City only.
10. The tender must accompany the self attested copy of PAN Card, GST Registration Certificate and FSSAI license.
11. The last date of receipt of tenders is 07.06.2018 upto 1.00 PM and will be opened on the same day at 3.00 PM in the presence of the tenderers or their authorised representatives. The conditional tender will not be accepted.
12. If the office happens to be closed on the date of receipt, then the tenders as specified, will be received and opened on the next working day at the same time and venue. However, the Federation reserves the right to extend the due date for submission of tender and date of tender and under such an event, the same will be communicated to all the concerned in advance.
13. The tenders should have "TENDER FOR WHITE BUTTER" superscribed on top of the envelope and addressed to the Managing Director, The Punjab State Cooperative Milk Producers Federation Limited, SCO no.153-155, Sector:34A, Chandigarh-160022.
14. Managing Director, The Punjab State Cooperative Milk Producers Federation Limited, Chandigarh reserves the right to accept any or reject any or all the tenders without assigning any reason whatsoever at any point of time.
